Dear Vendor:

Welcome to Caribbean Days 2010. **Applications are now being accepted from Vendors wishing to participate in our 23rd Annual Caribbean Days Festival, (July 24 & 25).** The information provided is mainly for those of you who are new and not fully acquainted with the concession requirements particular to the south side of the park, normally referred to as the Southside.

The stage, live entertainment, kids and family activities are on the Southside. This location is reserved for novelties, rides and self-contained mobiles. Jamaican patties, Samoa, Wraps and other items of that nature shall be sold only on the “NORTH-SIDE”. **Please note: Only our youth corps shall be permitted to sell hotdogs and hamburgers.**

The following are examples of some of the items permitted on the Southside.

Novelties: Arts& Crafts, apparels, jewelry, hammocks, sealed or bottled items, etc.

Mobiles: Coffee, donuts, candies, ice cream and pre-wraps. Mobiles and other units must be fully Self-contained.**WE DO NOT PROVIDE WATER & ELECTRICTY ON THE SOUTHSIDE**

Concessionaires that provide edible items must attend the meeting to be scheduled with the North Shore health department in attendance and should attach a list of the products to be sold along with their application forms.

We thank you for your interest in participating in this year’s Caribbean Days Festival and hope that you will find it richly rewarding.

To ensure your space, please fill out and submit all applications with your remittance early. Spaces are offered on first come basis when all payments stipulated on the attached or enclosed forms are made as required.
